The event was co-emceed by television personality Joel Jackson and Channel 7's Angela Tsun. Joel also delighted the crowd with his singing skills during the event.

Once official proceedings were concluded, guests took to the dance floor and partied to sounds of Western Australian band, Darren Reid and the Soul City Groove.

The WA Day Festival was a success, with packed events at Elizabeth Quay in Perth and the Fremantle Esplanade. The main event at Elizabeth Quay was State of the Art, a free music festival headlined by WA bands Jebidiah, San Cisco and Ta-ku, with support from more than 80 emerging and professional WA musicians.

Thousands of people attended events across Western Australia in Mandurah, Albany, Kalgoorlie-Boulder, Geraldton and Port Hedland. These regional programs were very well received.

Robert was also the 2015 Western Australian of the Year.

The Western Australian of the Year Awards recognise the highest level of contribution made to the state by those born and bred in Western Australia, or those who have chosen to make Western Australia their home.

In 2016, the Awards profiled seven sectors including Aboriginal, Arts and Culture, Business, Community, Professions, Sport and Youth. From these categories, Adrian Fini OAM was named Western Australian of the Year for 2016.





ADRIAN FINI OAM

Winner, Western Australian of the Year 2016.

Winner, Business Award. Sponsored by Telstra.

Adrian Fini OAM has been involved in the Perth property industry for over 30 years. As Managing Director of the Fini Group and a Director of FJM Property Pty Ltd, he has overseen a portfolio spanning hospitality, retail, property development and property investment. Recently, Adrian and his team restored the State Buildings and COMO The Treasury to their original splendour, revitalising a precinct of beautiful buildings on St George's Terrace for public use. He is currently working on several new major projects, which will further drive vibrancy and commerce in the City of Perth. Adrian is a Board member of The University of Western Australia Business School and their New Century campaign; the Perth International Arts Festival; and, Chair of the Art Gallery of WA Foundation. Adrian was awarded an OAM in 2014 for his contributions to the arts.



RISHELLE HUME

Winner, Aboriginal Award. Sponsored by Wesfarmers.

For over 20 years, Rishelle Hume has devoted her working life to advancement of Aboriginal peoples and Noongar culture. She is actively involved in the Perth Aboriginal community as the Chairperson of the Mandjah Boodjah Aboriginal Corporation, Co-Ambassador of the Yorga Dienna Bidi Leadership Program, Council Member of the Noongar Charitable Trust Advisory and Director of the Noongar Wellbeing and Sports Association. Rishelle has added value to Aboriginal advancement in Western Australia by demonstrating Aboriginal leadership and coordinating approaches to dealing with state Aboriginal matters. Her work ranges from employment and education to justice and health.

Rishelle, a mother of three, is a proud Noongar woman with traditional ties to the Whadjuk, Ballardong and Gnaala Karla Booja peoples. She is a direct descendent of highly respected Noongar elder Patrick Hume, who spent his life tirelessly promoting Aboriginal rights and Noongar culture. Rishelle has a Bachelor of Commerce with a Double Major in Human Resource Management and is the Senior HR Aboriginal **Employment Consultant with** Chevron.



WARWICK HEMSLEY

Winner, Arts and Culture. Sponsored by Woodside.

Warwick Hemsley is well known for his philanthropic contributions to Western Australian arts. Through his leadership skills, he has helped improve business models and financial performance of the state's arts organisations. In addition to his generous and ongoing financial support, Warwick's leadership will be his lasting legacy and his most defining contribution to the sector. His underlying commitment has been to help leading arts groups become sustainable, and so enabling them to continue enriching the cultural life of all Western Australians.

Warwick has a long history with the property profession, having served as Managing Director of valuation and commercial property practice DTZ (WA) for some years, Chief Executive Officer of property group Peet Ltd for 17 years, Chairman of the Housing Industry Forecasting Group and President of the Urban Development Institute (WA), amongst various other professional roles. He has also served in leading management and guiding roles either as Chairman, Deputy Chairman, board member or supporter of many significant institutions and organisations. These include the WA Chamber of Commerce and Industry, the Urban Development Institute, the Housing Industry Forecasting Group, the Anglicare Winter Appeal Committee, the Winston Churchill Memorial Trust, the Curtin Business School, the WA Opera, the National Gallery of Australia, the Art Gallery of Western Australia Foundation, and the Chamber of Arts and Culture WA.



DR JOHN VAN BOCKXMEER

Winner, Community. Sponsored by Alcoa of Australia Ltd.

As a doctor in the Pilbara. Dr John van Bockxmeer has dedicated himself to improving the health of Western Australians, John founded the not-for-profit organisation Fair Game Australia, which uses recycled sports equipment to deliver fitness and wellness activities to people in need. The charity has donated over 15,000 items of recycled equipment and continues to inspire change through fitness, capacity-building and health education programs. John also co-founded FuturePerth. a voice of progress that will ensure development in Perth is vibrant, integrated, sustainable, and reflects aspirations of its citizens. For more than ten years he has promoted excellence in the fields of medicine and community development in local, national and international initiatives. John is also a board member of several prominent volunteering and education peak bodies and institutions, including the Australian College of Rural and Remote Medicine, Volunteering Western Australia, and FuturePerth Inc.



ARLENE CHAN

Winner, Professions Award. Sponsored by St John of God Health Care.

Professor Arlene Chan is a breast cancer-specific oncologist at Hollywood Private Hospital where she is also Director of the Breast Clinical Trials Unit. Her other professional positions include Adjunct Professor at Curtin University Medical School and vice chair of the Breast Cancer Research Centre of WA. Arlene graduated from the University of Melbourne Medical School. She obtained her Fellowship in Medical Oncology from the Royal Australasian College of Physicians and a Masters of Medicine in Palliative Care from Melbourne University. She was also awarded a breast cancer fellowship from Princess Margaret Hospital in Toronto. Arlene established the not-forprofit organisation, the Breast Cancer Research Centre -Western Australia in 2009.

Arlene heads the busiest breast cancer clinical trials unit in Australia. She has recruited over 1,000 patients into 79 trials and results from several of these trials have led to a worldwide change in the standards of care for breast cancer. She also established the first breast cancer tumour bank in Western Australia where over 2,500 tissue samples are stored for future research.



NATHAN 'NAT' FYFE

Joint Winner, Sport.

Nat Fyfe is a professional AFL player currently playing for the Fremantle Football Club. Nat was selected by the Fremantle Dockers in the 2009 AFL Draft, and won the Rising Star nomination for Round 9 of the following season. Nat has since won numerous awards for excellence including the 2015 Brownlow Medal. A leader in his hometown of Lake Grace. Nat regularly returns to take part in functions and sporting activities with the local children. Nat's contribution to WA agriculture was highlighted in the wool industry's Fibre of Football campaign where he explained his relationship with the wool industry through his family's transport business. In 2015, Nat mentored nearly 3,500 young people through school training programs, school holiday programs and clubs.



CAITLIN BASSETT
Joint Winner, Sport.

Caitlin Bassett is one of Australia's most recognisable sportswomen. She is an Australian netballer playing in the Australian Netball Diamonds and represents West Coast Fever in the ANZ Championship. Her contribution in the Australian Diamonds helped seal the 2011 World Championship for Australia. As a Telstra Ambassador for the past four years, Caitlin has educated young people about self-confidence and bullying through the Cyber Safety and Standing Tall programs. To prepare for these programs, Caitlin intensively researched cyber safety and consulted with child psychologists. Caitlin is currently completing her degree in Communications, majoring in Broadcasting and Journalism. She has also studied sport, exercise science and nutrition.



ASHLEE HARRISON
Winner, Youth.

As founder and CEO of mental health charity zero2hero, Ashlee Harrison is motivated by a vision of a nation where there is no stigma around discussion of mental health. She aims to ensure young people are educated and empowered to effectively deal with mental health issues. zero2hero was formed after Ashlee noticed a gap in mental health education before the point of crisis. She set up the charity at the age of 21 with the aim of ensuring young people are educated and empowered to effectively deal with mental health issues. Ashlee leads a team of staff and volunteers who reach over 80,000 young Western Australians every year.

Over her seven years working in the sector, Ashlee has partnered with organisations including Lifeline, Suicide Prevention Australia and the Foundation for Young Australians. She was recognised by the Australian Financial Review as one of Australia's 100 Women of Influence, awarded a Pride of Australia Medal in 2015, the WA Youth Award for Education in 2013, and, in the same year, was also a Young Australian of the Year finalist.

WA Day Festival

Every year on WA Day, Western Australians celebrate all of the great things about our people, lifestyle, culture, and potential.

This year on Monday 6 June the popular concert, State of the Art

(SOTA), and Come Out and Play event were held as a combined, free, one-day celebratory event at Elizabeth Quay for the WA Day Festival.

Western Australians of all ages participated in a range of free activities and attractions including interactive arts and cultural projects; circus skill workshops; interactive theatre from the team at Shakespeare Shenanigans; and, a range of sports.

Despite inclement weather, the WA Day Festival at Elizabeth Quay drew an estimated 30,000 people, with more than half filling the event by noon. Attendance was higher than last year, with crowds being attracted by the free activities and great SOTA

line up. The SOTA site reached capacity of 4,500 by 5pm, and 15,000 people entered the licensed area throughout the day.

State of the Art

The main event at Elizabeth Quay was State of the Art, a free festival headlined by WA bands Jebidiah, San Cisco, and Ta-ku. Support was provided by more than 80 emerging and professional WA musicians. SOTA ran from noon to 9pm.

Presented by Celebrate WA and curated by Western Australian Music, the SOTA festival aimed to deliver a high quality WA music program from a range of local artists. The event was specifically targeted to 18 to 35 year olds and focused on building a music legacy in the city for years to come.

The SOTA brand has developed its own identity and is seen by 15 to 25 year olds as a legitimate festival event on the Perth scene. The popularity and awareness of SOTA continues to grow from year to year, and furthers the position of contemporary music as a leading cultural identifier for WA.

Fremantle

More than 4,000 people attended WA Day Festival events at the Fremantle Esplanade.

The Literature Centre partnered with Celebrate WA and the WA Department of Education to present a range of school workshops. Students exhibited writing and illustrations reflecting their favourite Western Australian person or place. The Literature Centre also presented two free workshops for children with WA author Raewyn Caisley and illustrator Karen Blair.

Esplanade Youth Park

Skateboarding WA held a wellattended skateboarding clinic.

Little Creatures Jetty

Visitors explored the fascinating

16th century Dutch replica ship, learning about early European exploration to Western Australia.

Other Fremantle Esplanade events included art classes, African drumming circles, face painting, kite exhibitions, live music performances, numbat mask making, and a huge range of food trucks.

Amongst fundraising efforts, the Fremantle PCYC raised funds through the Coles Community Barbeque.

Mandurah

Despite freezing conditions and threat of a major storm, an estimated 3,000 people ventured out to Tuckey Street for the Mandurah Winter Street Party. Residents were proud to celebrate the multicultural diversity of the Peel Region through music, dance, food and entertainment.

The 'FIRE' themed event opened with a Smoking Ceremony.
The street was festooned with lanterns, fire pits blazed, and a fire twirler wowed the crowd.

The fire pits created an "aroundthe-campfire" feel, warming patrons and acted as a magnet for groups to sit and chat.

Performances of Aboriginal dreamtime stories in dance, Balinese traditional, Filipino bamboo dancing, as well as Kung Fu and Tai-Chi demonstrations.

Celebration Tree

Members of the community penned their thoughts about what they loved most about Western Australia on a handcrafted length of fabric. Participants then joined the fabric to several lines of twine attached to a tree that was ablaze with lanterns.

The Youth on Leadership group raised over \$1,100 through the Coles Community Barbeque.

Albany

In Albany, the WA Museum created a free festival event attended by more than 3,250

people. Almost 50 community groups joined in.

Kids enjoyed a bouncy castle, face painting with the Albany Girl Guide Troop, kite making with the Young Naturalists Club, puppet making, and Jamie the Clown. The Albany Pony Club provided pony rides. Reptile Haven brought along some scaly friends for visitors to see and hold

Kalgoorlie-Boulder

In Kalgoorlie-Boulder, more than 3,300 people attended festival events put on by the WA Museum.

Artback ran an art workshop for ages 3-12 and KBULG ran a nature craft workshop. Urban Indigenous organised a Community Canvas to entertain the families.

Mini Jam

Held within the Museum, children learned about video game development and coding. This event was held in the lead up to the International Game Jam in January 2017.

Performances and live music

The Kalgoorlie Dance Academy and The Lulus entertained visitors throughout the day while JetPack and the China Blue Experiment provided live music.

Food

The Coles Community Barbeque helped raise \$1,685 for North Kalgoorlie Primary School.

Geraldton

In Geraldton, the WA Museum received enormous support from volunteers and other organisations, helping provide a lively and amazing festival. More than 3,500 visitors attended.

EVENTS INCLUDED:

The Main Arena

Visual artist Phil Doncan set the scene in the Main Arena with his ten metre dynamic Mid West canvas. He drew from various themes reflecting traditional owners and ancient beginnings of the land, along with landscapes and the region's favourite pursuits. Other performers included Ashton Kate, Beck Tuesley and New Folks. The Main Arena also featured the Community Canvas.



A Taste of WA

The Taste of WA Zone highlighted the cultural diversity of the community with different styles of food, including Mexican, crepes, and burgers.

Youth Arena

Museum Place was transformed with a mechanical surfboard, geocaching, minkey hockey, tarp surfing, circus performances, graffiti art, and an 8.5-metre climbing wall. Perth hip hop trio Vilified Solutions also performed.

In the Wild

Hop Upon a Pony, Greenough Wildlife Park, Just Raptors, Old McDonalds Farm, Drylands Permaculture Nursery and Friends of Geraldton Gardens filled up the space with flora and fauna exhibits.

The Geraldton Junior Soccer Association and the Geraldton

Greenough Farmers' Market raised more than \$1,500 through the Coles Community Barbeque.

Port Hedland

In Port Hedland, activities were spread over the long weekend. More than 2,000 people attended the West End Markets, 15 attended the weaving workshop, and 500 attended the Spinifex Hill Studios. 95% of survey respondents felt the events held over the weekend were important to the Port Hedland community.

EVENTS INCLUDED:

Maker workshop and public installation with Emma Davies.

The community contributed to a large-scale installation using recycled wool, rope and colourful material.

Mural making with Ted Byrne

Spinifex Hill Artist Ted Byrne facilitated a mural painting station using a three metre length piece of canvas. Byrne selected the palette and theme for the mural, "Our Community". Children were encouraged to paint their favourite parts of Western Australia onto the mural.

Local musicians

Bill Gardiner headlined the musical line up at the Spinifex Hill Studios. In addition, local musician Greg Taylor and artist Ted Byrne performed, as well as DJ Amy Mukherjee.

Spinifex Hill artists showcase

The community learnt about the unique cultural heritage and artistic processes of local Aboriginal artists Maggie Green, Annabella Flatt and Charlie Njara.

Weaving with Fiona Gavino

The community explored traditional craft with the traditional owners of Western Australia in an open weaving session in the garden of the Spinifex Hill Studios.







Programs

COMMUNITY CANVAS

Urban Indigenous facilitated this year's Community Canvas project, delivering six collective canvases throughout the State. Aboriginal artists Joey Williams, Sheila Humphries, Jade Dolman, Neta Knapp, Wayne Dekker and Teddy Byrne demonstrated the art of painting and Aboriginal storytelling, helping to enhance the understanding of their peoples' community, culture and identity. These events were held in Albany, Kalgoorlie-Boulder, Perth, Mandurah, Geraldton and Port Hedland.

SOUNDS OF THE GOLDFIELDS

WAM's Sounds of the Goldfields project highlighted the rich vein of musical talent running through the Goldfields.

A CD featuring ten diverse artists was launched on Saturday 28 May to a sold out audience at the Goldfields Arts Centre. The launch featured live performances from all featured artists plus special guests Eskimo Joe. The CD was a huge success and sold 800 copies. GWN7 called the launch "the Goldfields' night of nights."

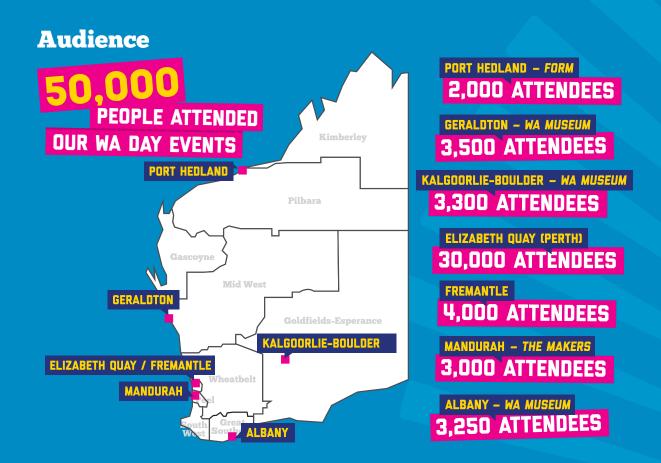
Along with guest sessions from Eskimo Joe's Joel Quartermain, Sounds of the Goldfields saw award-winning engineers Matt Gio and Sean Lillico work with the ten Goldfields artists.

EDUCATIONAL RESOURCES

The Educational Resources project was a collaborative activity between the Department of Education and Celebrate WA. The project provided opportunities for Western Australian public primary schools

to develop a sense of what it means to be Western Australian. It also provided cultural and contextual learning opportunities for regional Western Australian public primary schools and their communities.

The project consisted of a total of 32 resource packages including teacher guides, activities and tasks addressing Humanities and Social Science, Arts, English, and Sciences. There were also a series of literature workshops involving a writer and illustrator working with students in years three to six. Workshops were held in Padbury, Karratha and Katanning, Lastly, an Aboriginal English storybook program helped develop contextually and culturally appropriate story books. This program featured a writer working with remote Western Australian schools and local Aboriginal organisations.

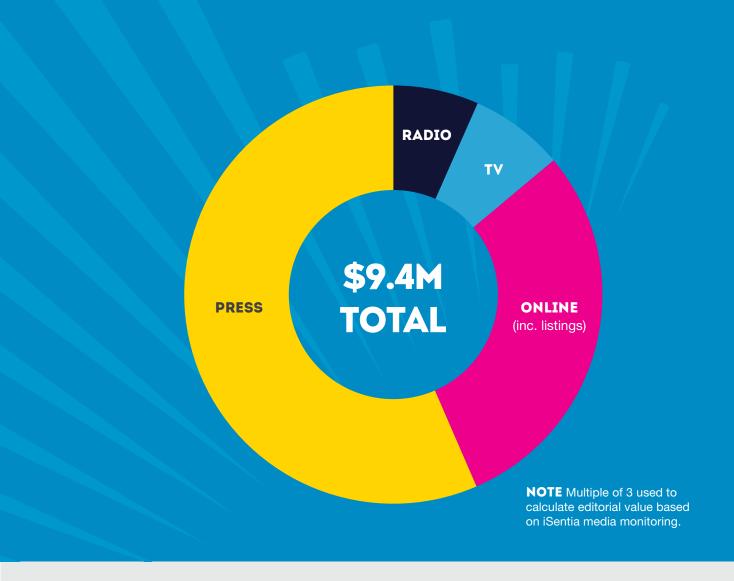


Marketing Highlights

Earned Media Value: WA Day campaign

Significant media coverage was achieved in 2016 through established media partnerships and other media opportunities created for WA Day.

Media partnerships with The West Australian, Channel 7 and Southern Cross Austereo (94.5 and 92.9) were successfully leveraged resulting in a high calibre of media coverage over the campaign period. This included six major branded opinion pieces in The West Australian, a masthead change in The West Australian for WA Day, three features and a weather cross on Channel 7. Radio coverage across the state included competitions, interviews with Award nominees and a live broadcast from WA Day Festival at Elizabeth Quay.

Media personalities also featured in WA Day videos that were shared extensively on social media.

Channels 7, 9, 10 and ABC covered the Western Australian of the Year Awards.

Coverage was also achieved from non-media partner outlets including ABC720, 6PR, The Sunday Times, Channel 9, Channel 10, GWN, community newspapers, regional newspapers and radio.

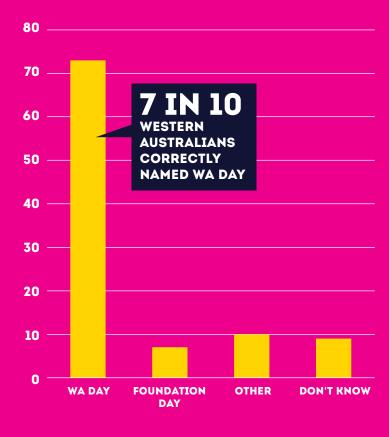
In 2016, we conducted marketing research with the general public of Western Australia.

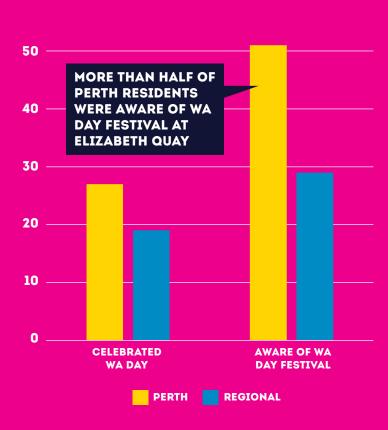
Research confirms that WA Day has successfully changed its name from Foundation Day, with seven in ten Western Australians correctly naming the day.

Note 1: Statement of Significant Accounting Policies

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Association's constitution. The Board has determined that the Association is not a reporting entity.

Celebrate WA Inc (the Association) is a not-for profit incorporated association that was domiciled in Western Australia. The Association is responsible for promoting and organising the annual WA day celebrations, promoting excellence and achievement by Western Australians in all fields of endeavour and encouraging pride in all things Western Australia.

The special purpose financial statements have been prepared in accordance with the recognition, measurement and classification aspects of all applicable Australian Accounting Standards (AASBs) adopted by the Australian Accounting Standards Board (AASB). The special purpose financial statements include only the disclosure requirements of the following AASBs and those disclosures considered necessary by the Board to meet the needs of members:

AASB 101 Presentation of Financial Statements

AASB 107 Statement of Cash Flows

AASB 108 Accounting Policies, Changes in Accounting Estimates and Errors

AASB 1048 Interpretation of Standards

AASB 1054 Australian Additional Disclosures

The financial report has been prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The financial statements are presented in Australian dollars, which is the Association's functional currency.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

(a) Income tax

No provision for income tax has been raised as the association is exempt from income tax under Division 50 of the Income Tax Assessment Act 1997.

(b) Property, plant and equipment (PPE)

Plant and equipment

Property, plant and equipment is measured on the cost basis less depreciation and impairment losses.

The carrying amount of fixed assets is reviewed annually by the Board to ensure it is not in excess of the recoverable amount of those assets. The recoverable amount is assessed on the basis of the expected net cash flows which will be received from the assets employment and subsequent disposal. The expected net cash flows have not been discounted to present values in determining recoverable amounts.

Depreciation

The depreciable amount of all fixed assets are depreciated on a straight-line basis over their useful lives to the Association commencing from the time the asset is held ready for use.

(c) Financial instruments

Cash and cash equivalents

Cash and cash equivalents comprise cash on hand, cash at banks and on call deposits with a maturity of less than 3 months of the date the deposit was placed.

Trade and other receivables

Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

Trade and other payables

Trade and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the Association during the reporting period which remains unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

Note 1: Statement of Significant Accounting Policies continued

(d) Employee benefits

Provision is made for the Association's liability for employee benefits arising from services rendered by employees to balance date. Employee benefits that are expected to be settled within one year have been measured at the amounts expected to be paid when the liability is settled, plus related on-costs. Employee benefits payable later than one year have been measured at the present value of the estimated future cash outflows to be made for those benefits.

(e) Revenue

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest rate method, which for floating rate financial assets is the rate inherent in the instrument.

Sponsorship income and pledge donations are recognised in the Statement of Profit or Loss when the Company obtains control of the income/donations or the right to receive it and it is probable that the income/donations will flow to the entity and the amount can be measured reliably.

Donations, gifts and government grants are recognised in the Statement of Profit or Loss when the Company obtains control of the contribution or the right to receive it and it is probable that the contribution will flow to the entity and the amount can be measured reliably. Income on donations received 'in kind' is recognised at the fair value of the donation.

All revenue is stated net of the amount of goods and services tax (GST).

(f) Goods and services tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Tax Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the statement of financial position.

(g) Government grants

Government grants are recognised as revenue in the period when control is obtained. If the revenue transfer is non-reciprocal, then grants are recognised on receipt.

(h) Lease payments

Payments made under operating leases are recognised in profit or loss on a straight-line basis over the term of the lease. Lease incentives received are recognised as an integral part of the total lease expense, over the term of the lease.
